Proclamations and Presentations

Mayor Ling read and presented a proclamation to Kim Tollenaere and Larry Collins welcoming the student delegates from our Sister City Okaya, Japan.

Mayor Ling read and presented a proclamation to William Miller, with Papas Pumpkin Patch, recognizing "National Farmers Market Week – August 4 thru 10, 2013".

Mayor Ling presented a Neighborhood Mini Grant to Brian Sponseller representing the Glenwood Place Neighborhood Association.

Barb Subastian of the Liquor Control Commission gave a presentation regarding recent changes to the liquor licensing process.

Discussion ensued.

- 4. Work contract with Central Michigan University in which CMU will commit to reimburse the City \$19,790 for added cost of meeting a change in specifications for the Bellows Street sidewalk replacement project.
- 5. Change order to Bellows Street sidewalk replacement project contract with Isabella Corporation in the amount of \$19,790.

Moved by Commissioner Holton and supported by Commissioner Rautanen to rescind the Motion of July 8, 2013 regarding Special Assessment #1-13. (Rescinded motion provided below in bold italics for clarity.)

Moved by Commissioner Holton and supported by Commissioner English to direct staff to create revised resolutions to only include the 900 and 1000 blocks of South Washington and respread the assessment roll accordingly.

Moved by Commissioner Holton and supported by Commissioner Rautanen to enter into closed session pursuant to Section 8(c) of the Open Meetings Act for strategy and negotiation sessions connected with negotiations of a collective bargaining agreement.
